This Memorandum of Understanding (hereinafter called as the "MOU") is entered into on this the DAY of Two Thousand and Twenty-Two by and between BUNDELKHAND UNIVERSITY JHANSI, UTTAR PRADESH State University, hereinafter referred to as First party, and BHARAT HEAVY ELECTRICALS LIMITED, JHANSI, UTTAR PRADESH INDIA hereinafter referred to as Second Party.

This Memorandum of Understanding (the "MoU") is entered into at Jhansi on the 30th day of September 2022.

BETWEEN

Bundelkhand University, Jhansi, a premier Institution of excellence in Engineering and Management (Hereinafter referred to as BU Jhansi which expression shall unless the context or meaning thereof be otherwise repugnant mean and include the executors, administrators, assigns) of First part.

AND

Bharat Heavy Electricals Limited (BHEL) TP, Jhansi, a unit of BHEL-a major public sector Maharatna company and a leading power plant manufacturer in India established by the Government of India registered under the Companies Act, 1956 and having its Registered Office at BHEL House, Siri Fort, New Delhi -110 049/ Hereinafter referred to as BHEL Jhansi which expression shall unless the context or meaning thereof be otherwise repugnant mean and include the executors, administrators, assigns) of Second part.

WHEREAS

- Bundelkhand University, Jhansi is desirous to impart education, Knowledge, Skill development and Personality Development Training etc.
- BHEL TP, Jhansi is a unit of BHEL- one of the largest engineering enterprises in India promoted by Government of India and a leading power plant manufacturer in India and takes credit for 73% of installed thermal power capacity in the country. BHELJhansi is one of the Famous units of BHEL and is currently engaged in design, manufacture and erection of utility and industrial.

1. Objectives of the MoU:

In particular, this MOU is intended to build a long term relationship and develop healthy and stable arrangement between both the parties to recognize and strengthen institute-industry interaction. The forms of programs may include but are not limited to –

- 1.1 To strengthen Institute-Industry interactions.
- 1.2 To share knowledge in areas of mutual interest.
- 1.3 To share resources for mutual benefit.
- 1.4 Training for Students (Summer/ Vocational Training)
- 1.5 Guest/ Invited Lecture Workshop
- 1.6 Industrial Visit & exposure

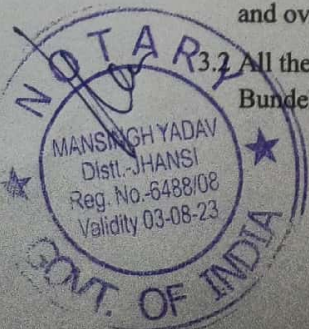
2. Fields/ Areas of Interaction:

- 2.1 Faculty from BU Jhansi may be deputed to BHEL Jhansi for training in specific areas on mutually agreed terms.
- 2.2 Engineers of BHEL Jhansi may be sent to BUJhansi for getting exposure to the latest techniques in various fields which are relevant to BHEL Jhansi's operations.
- 2.3 A Mutually agreed number of executives of BHEL Jhansi shall be enrolled for various specialized courses such as MS/PhD/PG, conducted by BU Jhansi.
- 2.4 Whenever BU Jhansi invites foreign experts under Faculty Exchange. Programmes, the services of the foreign experts may be extended to BHEL Jhansi for exchange of knowledge.
- 2.5 Jointly conducting need-based short term courses, seminars, and symposia on mutually agreed terms.
- 2.6 Utilizing the infrastructures and facilities available at both the organization in relevant areas of interest for mutual benefits under mutually agreed terms.
- 2.7 Joint projects, both on short term and long term basis, which are of interest to BHEL Jhansi and BU Jhansi will be identified and implemented on mutually agreed basis.

3. Review and Monitoring:

3.1 A committee consisting of members from BHEL Jhansi and from BUJhansi will meet periodically and oversee the operation of this MoU and resolve any issue that may emerge.

3.2 All the activities under this MoU will be coordinated by HRDC, BHEL TP Jhansi and IMS, Bundelkhand University, Jhansi.

4. Confidentiality and IPR aspects:

- 4.1 Each party shall be obliged to keep in strict confidence, and bind all of its employees associates and subcontractors to keep in strict confidence all information received directly or indirectly from the other party under this MoU and shall not at any time, disclose such information to any third party without prior written consent of the other party.
- 4.2 The Information shall be utilized for the specified purpose only for which it is meant.
- 4.3 Neither party shall disclose or publish or commercially utilize the details of the joint projects without the written consent of the other party.
- 4.4 In case a patentable invention is made by a student during the joint project work, his/her name will be included as one of the co-inventors along with the other scientists who have contributed for the invention. BHEL Jhansi will apply for the patent, own and maintain the patent as per its normal practice.





5. Duration of the MoU:

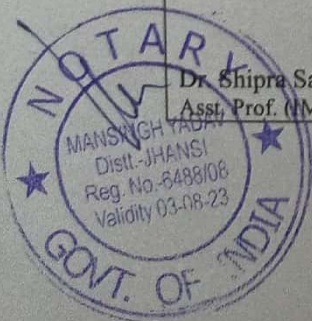
