### BY AND BETWEEN

### AND

**Entrepreneurial Development Council** company registered under the section-8 of Companies Act . Bharat having its main office at EDC INDIA C Block, AITM, Rooma Kanpur, Uttar Pradesh (hereinafter referred to as “**EDC INDIA** ” which expression shall, unless it is repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns).

The **Bundelkhand University** and the **EDC INDIA** are hereinafter referred to as the “**Party**” and collectively as the “**Parties**”.

### WHEREAS:

- D. **EDC INDIA** and **Bundelkhand University** have discussed and explored possibilities and areas for collaboration with each other and hence, the parties enter into this understanding to agree upon a broad framework for their collaboration and support.

**NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL UNDERSTANDINGS, COVENANTS, REPRESENTATION, AND WARRANTIES SET FORTH IN THIS UNDERSTANDING, THE PARTIES HEREBY AGREE AS FOLLOWS:**

1. **EDC INDIA** and **Bundelkhand University** agrees to mentor and train students through Campus to corporate program on mutual consent. Also, EDC India will provide one month internship to the students during the program for better learning and corporate experience.
2. **EDC INDIA** and **Bundelkhand University** have agreed to collaborate to Support a Placement Cell for JOB /Internship at Bundealkhand University Campus.
3. **EDC INDIA** and **Bundelkhand University** will work to collaborate and cooperate with each other to support the needs of students as mentors, Career Counsellor, and accelerators.
4. **EDC INDIA** and **Bundelkhand University** Through Campus to Corporate program EDC India will help the students to gather practical exposure of the corporate world.
5. **EDC India** promises to develop sustainable incubation program at University on the mutual consent. And help startups in raising funds from the investor chain of more than 750 angel investors.
6. **EDC India** agrees to groom startups and entrepreneurs to design their pitch decks on their own and not to waste more than 50000 to someone else for designing their decks..
7. **EDC India** shall provide job/internship opportunities to the students of **Bundelkhand University**. Also, help students in landing their dream job.
8. EDC INDIA agrees to provide scholarship and incentives to the students of Bundelkhand University who are participating in the Campus to Corporate program.
9. **Bundelkhand University** shall provide the partners of **EDC INDIA**, a mutually agreed representation, in its Committee(s) formed for the various programs which select the startups for incubation and support. The Parties will formalize subsequent processes to implement this MoU.
10. The Parties, if any additional detailing is required, would work together to execute, within the next 90 days, a definitive Agreement containing the various terms and conditions including any commercial terms, under which the Parties would collaborate in the future.
11. This Understanding shall not be deemed to constitute any kind of partnership, agency, or contract of employment of whatever nature between the Parties and no Party shall have
