ARTICLE 2: AREAS OF COLLABORATION

The parties hereby agree to work collaboratively on following objectives for the effective and efficient engagement by fulfilling the purpose of this MoU towards strengthening and streamlining teaching, research in scientific and technology development, innovation and entrepreneurship.

2.1 Objectives of the Agreement

- The objectives of the MoU will include programs offered at either party which are felt to be desirable and feasible for the development and strengthening of expertise in the various fields to expand the opportunities in the research, especially translational research and industrial collaboration, besides the development of human resources to face the future challenges & the cooperative relationships between the two institutions.
- It also includes the exchange of ideas on research publications, academic programs and research projects and promotion of technology, incubation and start-ups".
- Such programs may include any or all of the following activities:
 - a. Exchange of faculty and researchers
 - b. Promotion of collaborative research in areas of mutual interest
 - c. Development of short-term academic and training programs
 - d. Participation of jointly organized academic meetings, seminars, and workshops
 - e. Any other areas which the parties agree are in their mutual interest.

2.2 Scope, Goals and Forms of Cooperation

- The signing institutes agree to provide opportunity as appropriate for the following activities towards the completion of the objectives of this MOU:
 - a. Exchange of ideas with the objective of offering mutually developed courses after approval of concerned bodies of university (Short Term Certificate, Diploma Courses) and realizing research projects in areas mutually agreed upon by both parties through prior invitation and in accordance with the procedures and expectations established by each institute and specific department.

- b. The both parties will provide research supervision (co-supervisor or assign faculties) and support in various fields as on the demand of either party for conducting research related to the thesis/dissertation requirements of the students and research scholars.
- c. Operational details of research effort and collaboration will be made in common research programmes and/or projects restricted to specific mandated domain within the approved disciplines divisions.
- d. Research instrumentation facility and library facilities available at both institutions will be made available to the faculty, students, and research scholars. However, the costs of specific consumables will be borne by the respective organizations/researcher/students as per the mutual concern or rule of concerned institution.
- Exchange of scientific publications, study programs, academic projects, course information, seminars, conferences, and any other data and information of common interest.
- f. Both the Institutions will develop joint research projects; promote incubation technology, start-ups, organization of seminars, symposia, workshops for benefits of the students.
- g. Submitting proposals jointly to various Central/State Department Organization under different Schemes using each other's competencies by mutual consent.
- All joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations of the appropriate institute entity.

It is also agreed that:

- Annual Faculty and Students exchange program will be held between both parties as part
 of understanding the academic, social and cultural diversities and also provide basic
 infrastructural facilities (food and lodging) during their visits.
- ii. Both parties will provide training course completion certificate branded by *Veer Bahadur Singh Purvanchal University* and *Bundelkhand University*
- iii. Faculties of both parties will share their own developed/published e-contents, lectures, videos, research articles to each other for use of academic purposes.
- iv. Both parties will prepare a training calendar for the academic year that is found suitable for the students of the concerned departments.

2.3 Exchange of Information

- The term "information includes scientific or technical data results and/or methods of investigation, and other information intended to be provided, exchanged, or arising under project descriptions entered into pursuant to this MOU.
- The parties support the widest possible dissemination of information. Each party in joint projects shall be given the right to use, disclose, publish or disseminate such information for any and all purposes.

ARTICLE 3: CO-ORDINATION AND NODAL OFFICER

Both entities shall mutually decide and designate a nodal officer. The nodal officer will have responsibility for fulfilling the objectives of this agreement and also will carry out all activities mutually agreed by the parties.

ARTICLE 4: IMPLEMENTATION OF THE MEMORANDUM OF UNDERSTANDING

- i. It is understood that the both parties subscribe to the principle of equal opportunity and do not discriminate on the basis of state, race, sex, age, cast or religion. Both the institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non-discrimination.
- Students, research scholars and faculties may visit the corresponding departments of the institute after finalizing a mutually acceptable schedule.
- iii. Faculties, Research Scholars, and Students from both institutions may access the resources such as laboratories, facilities (hostel, library, e-resources, guest house) during their official and academic visit of the institution without any financial aid (in case of prior prior approval of the visiting schedule and due approval from Heads of both Institutions.
- iv. Both parties promote research and realize collaborative projects giving priority to interdisciplinary works.

ARTICLE 5: Terms and Conditions

- i. This MOU shall become effective from the date it is signed by the parties and shall be valid for three years extendable up to five years. Both parties shall review the status of the MOU at the end of each three years period to determine any modification, whenever necessary. The period of validity of this MOU may be extended by mutual consent up to five years. This MOU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least six months in advance from the effective date of termination.
- All joint activities not completed at the expiration or termination of the MOU may be continued until their completion under the terms of this MOU.
- iii. No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MOU. The modifications/changes shall become part of the MOU and shall be effective from the date on which they are made / executed unless otherwise agreed.
- iv. Financial terms and conditions will be decided mutually as per needs of both parties. This MOU will be considered only for academic and R&D purposes only by both parties.
- v. This MOU and all confidential information exchanged between the Parties pursuant to this MOU shall be held in confidence.

- vi. Neither Party nor any of the affiliates shall make any public announcement about the MOU and /or the scope of proposed engagement, without the prior written consent of the other Party.
- vii. Both parties will take all necessary steps to protect the knowledge documents and intellectual Properties generated during the process or shared by the parties.

ARTICLE 6: ARBITRATION

- i. Any issues that are not addressed or stipulated in the MoU shall be discussed and resolved through negotiation in good faith and such resolution will be incorporated as written amendments to the MoU by mutual agreement between two Parties.
- ii. No disputes are foreseen in the implementation of the MoU. The two Parties, however, agree that if any dispute arises between them, efforts will be made to settle the same as amicably as possible. If the dispute still remains unsettled, it will be referred for resolution bilaterally to Vice Chancellors of Bundelkhand University, Jhansi and Veer Bahadur Singh Purvanchal University, Jaunpur. The decisions so arrived at shall be final and binding on the parties to this MoU.

ARTICLE 6: CONFLICT OF INTEREST

Neither of the parties believes that the Collaboration contemplated by this MOU raise any actual or potential conflicts of interest. The parties agree that this MOU and the negotiation of the same (and any other agreements entered into in connection herewith) are independent of any past, present or potential future arrangements, and are not connected to an existing professional relationship between either of the parties.

ARTICLE 7: TERMINATION

This MOU shall also terminate without liability to either party if otherwise agreed to by the Parties in writing with a notice period of 1 month.

ARTICLE 8: DISPUTE SETTLEMENT

8.1 Governing Law and Jurisdiction

- This MOU shall be governed by and construed in accordance with the laws of Republic of India. All disputes arising out of or related to this MOU, including without limitation all matters connected with its performance, will be governed by, and construed and interpreted under the laws of India, without reference to conflict of laws principles.
- All disputes and differences arising out of or in connection with this MOU shall be the first instance referred to arbitration by three (3) arbitrators, jointly appointed by Parties. The decision and award determined by such arbitration will be final and binding upon the Parties. The arbitration will be conducted in accordance with the Arbitration and Conciliation Act,
