MEMORANDUM OF UNDERSTANDING BETWEEN BUNDELKHAND UNIVERSITY, JHANSI AND

SAINT PETERSBURG ASSOCIATION FOR INTERNATIONAL COOPERATION (RUSSIA)

BUNDELKHAND UNIVERSITY, JHANSI (hereinafter referred to as BUJ) and the SAINT PETERSHURG ASSOCIATION FOR INTERNATIONAL COOPERATION (hereinafter referred to as SPbAIC) agree hereby to establish mutual cooperation relations which are intended to further academic, social and cultural objectives as well as to promote better understanding between the members (individual and collective) of both institutions (hereinafter referred to as Parties).

Under this Memorandum of Understanding (MoU), the Parties will proceed to implement the following endeavours and exchanges of materials, university personnel and association staff and members.

Areas of Cooperation

Mutual assistance shall be carried out, subject to availability of funds and the approval of the competent authority of the BUJ and SPbAIC, through such activities or programmes as:

- Joint activities in the fields of language teaching (including online classes and seminars), social and cultural work practices, and further possible projects agreed on by both Parties;
- Exchange of members;
- · Exchange of academic materials and other information.

The terms of such cooperation for each specific programme and activity that is implemented under the terms of this MOU shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular programme or activity and the terms of such programme shall be negotiated on an annual basis. Each institution will designate a coordinator for developing and implementing specific activities or programmes.

Scope of the Cooperation

The areas of cooperation include, subject to mutual consent, any programme on regional, national, or international level complying with the objectives set above as felt desirable and feasible on either side.

The assistance to be provided by each of the Parties in its geographic region will be organising and teaching in joint programmes, securing lodging for the participants in them and exchange members, assistance in supplying research, teaching and information materials to the other party, etc., as deemed beneficial by both institutions.

No Party has an obligation to bear the costs of any project within the framework of this MoU. In case participation in a project conducted under this MoU involves expenses (e.g. travel and living expenses, courses fees, costs of materials), the financing will be the responsibility of the participant.

The cooperation will be initially focused on the following activities:

- Non-university language teaching: organising Hindi and Russian programmes /intensive courses, including online classes and seminars;
- · Non-university cultural education: Indian and Russian culture;

Implementation

The MoU shall remain in force for a period of two years upon the date it is signed by the appropriate officials of the two institutions. It may be further extended or amended with the written agreement of both parties. This MoU may be terminated by either party through delivery of a termination notification in writing three months in advance.
