And

LTD.) is the online hiring platform which is live on Google with the name www.spiresrecruit.com and available on Play store with a name of 'Spires Recruit' where we are working for Employers and students of Tier3 College Students and who are unaware about finding the options of getting Internships, Jobs, Resume Building and Skills Development Programs. (hereinafter referred to as "SPIRES RECRUIT (Unit of Act T Connect Pvt. Ltd.)" of the second party.

(SPIRES RECRUIT (Unit of Act T Connect Pvt. Ltd.) and BU shall hereinafter be referred to collectively as "Parties" and individually as "Party" where the context so requires)

PURPOSE:

This Memorandum of Understanding (MOU) is established to outline the specific goals and objectives of the collaboration between Bundelkhand University Jhansi and Spires Recruit (Unit of Act T Connect) focusing on the areas of student Internships, Job Placements, Skill Development, and Training programs through Online and Offline.

RESPONSIBILITIES AND OBLIGATIONS

University Responsibilities:

- Identifying and recommending qualified students for internships and job placements.
- Coordinating with Spires Recruit to ensure a Smooth Internship and Placement Process.
- Supporting the integration of Skill development and training programs into the Bundelkhand University's curriculum.

Spires Recruit Responsibilities:

- Offering internship opportunities to students as per agreed terms.
- Assisting in job placements for university graduates.
- Providing relevant skill development and training programs.
- Collaborating on research and technology transfer projects as per mutual agreement.

Intellectual Property:

All intellectual property generated through this collaboration will be owned jointly by Bundelkhand University and Spires Recruit(Unit of Act T Connect Pvt. Ltd.), unless otherwise agreed upon in writing in accordance with applicable laws and regulations.

DURATION

This collaboration shall commence on the Nov,7 2023 of this MOU and shall remain in effect for a period of 5 years, unless terminated earlier by mutual written agreement of the Parties.

CONFIDENTIALITY

Both the parties agree to maintain the confidentiality of any non-public information shared during the course of this collaboration and shall abide by any additional confidentiality arrangements as may be mutually agreed upon. This obligation of confidentially shall survive the termination of this MOU.

FUNDING AND FINANCIAL TERMS

Both the parties agree that each initiatives under this MOU shall be funded as mutually agreed upon in writing prior to the commencement of the respective activity. Financial terms and responsibilities shall be detailed in separate agreements for each initiatives.

REPORTING AND COMMUNICATION

Both the parties shall communicate regularly to assess the progress of ongoing initiatives. Reports on the status and outcomes of internships, placements and Training programs shall be exchanges on a monthly basis through email or meetings as deemed necessary.
