This is the MOU reached between UNIVERSITI TUN HUSSAIN ONN having its headquarters at MALAYSIA hereinafter referred to as First party and BUNDELKHAND UNIVERSITY, Jhansi, Uttar Pradesh State University hereinafter referred to as Second Party.

UNIVERSITI TUN HUSSEIN ONN MALAYSIA. abbreviated as UTHM The university was formerly known as Pusat Latihan Staf Politeknik (PLSP) which was established on September 16 , 1993. The Malaysian government , on September 20 , 2006 , agreed to award the university-college a full university status and changed its name to Universiti Tun Hussein Onn Malaysia.

And whereas the Second Party BUNDELKHAND UNIVERSITY, Jhansi is desirous to impart education, Knowledge, Skill development, Personality Development, Training and Employment opportunities.

PURPOSE

The purpose of this MOU is to develop academic, educational, Practical exposure, work assignments, field visits, assisting in reporting and programme formation and other cooperation on the basis of equality and reciprocity and to promote sustainable partnerships and mutual understanding between the UNIVERSITI TUN HUSSEIN ONN MALAYSIA and BUNDELKHAND UNIVERSITY, JHANSI, UTTAR PRADESH, INDIA

SCOPE OF ACTIVITIES

UTHM and BU aim to undertake cooperation in areas that may include, but are not restricted to, the following:

- a) Student assistance and Exchange
- b) Joint research/programme activities
- c) Continuing education programs formation
- e) Research Guidance
- f) Education Field Visits/ Internship
- h) Other, with mutual consent of both the parties.

ACTIVITY AGREEMENTS

Before any activities may be implemented, the parties shall discuss the relevant issues to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the activity. Activity agreements will include such terms as the following:

- a) Elaboration of the responsibilities of each institution for the agreed upon activity.
- b) Specific schedules for the activity.
- c) Budgets and sources of finances for the activity.
- d) Detailed management of intellectual property rights and publications.
- e) Any other items deemed necessary for the efficient management of the activity.



RENEWAL, TERMINATION AND AMENDMENT

5.1 This MOU shall remain in force for a period of FIVE years from the date of the last signature. This MOU may be extended by the written consent of the parties.

5.2 This MOU may be terminated by either party giving written notice to the other party at least 180 days in advance of the stated termination date. Termination of this MOU shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.

5.3 This MOU may be amended only by the written consent of the parties.
