MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COLLABORATION

BETWEEN

DR. B.R. AMBEDKAR UNIVERSITY OF SOCIAL SCIENCES, DR. AMBEDKAR NAGAR

AND

BUNDELKHAND UNIVERSITY, JHANSI

Bundhelkhand University, Jhansi came into existence on August 26, 1975, vide Government of Uttar Pradesh Notification No. 10/15-60/74 under the provision of the U.P. Universities Act. The Bundelkhand University has fast transformed into a University of excellence with a mission to impart quality

vocational and scientific education through basic and applied research, to improve the quality and value of human irrespective of gender, caste, nationality and religion offering opportunities to the aspiring youths to pursue higher education.

Dr. B. R. Ambedkar University of Social Sciences, MHOW was established by the Govt. of Madhya Pradesh vide Act 2015 [Act No. 2 of 2016]. Dr. B. R. Ambedkar University of Social Sciences (BRAUSS) is the first university of social sciences in the country, mandated to accelerate higher education, research, extension and training in interdisciplinary and multidisciplinary subjects for social justice & emancipation, economic empowerment & development, educational excellence and socio-economic development, increasing participation of marginalized sections in decision making and nation building.

The representatives of **Dr. B.R. Ambedkar university of Social Sciences**, **Dr. Ambedkar Nagar (MHOW)** and **Bundelkhand University**, **Jhansi** agree to this Memorandum of Understanding. The Memorandum of Understanding (MoU) establishes the following

1. Objective of the MoU

- (A) To establish a mutually beneficial relationship built on academic and cultural cooperation.
- (B) Areas of Cooperation between Dr. B.R Ambedkar University of Social Sciences, MHOW and Bundelkhand University, Jhansi include the academic research and cultural interactions among faculty exchange of researchers and students, for research publication, academic programmes, cultural and research project internship.
- (C) To conduct study tour, a mutually agreed in writing between the both parties prior commencement of this actiion

2 Goals and Forms of Collaboration

The signing Universities agree to provide opportunity, as appropriate, for the following activities towards the completion of the objectives of this MoU.

1. Joint collaboration of students and /or researchers with the objective of offering courses and realising research, internship in areas mutually agreed upon by both institutes through prior invitation through and in accordance with the procedures and expectations established by each Institute and specific department.

- 2. Exchange of books publications cultural program academic projects, course information, seminars, lecture demonstration for workshop conferences and other data and information of common interest
- 3. Lectures of faculty members on special topics.
- 4. Organise joint activities will be realised through the mutual agreement and clearly established conditions and mutual obligations of the appropriate Institute entity.
- 5. Provide research guidance and extend facilities to conduct research leading to research degree including M.Phil, Ph.D, D.Litt, DSc.

2. IMPLEMENTATION OF THE MEMORANDUM OF UNDERSTANDING

The objectives of the MOU will be implemented and regulated in the following manner:

- i) Student Exchange
 - (a) Student and research scholars may visit the corresponding departments of these institutes after finalizing a mutually acceptable schedule.
 - (b) All the expenses shall be the direct responsibility of the student concerned subject to any agreements on payment arrangements made by either institution with its own students including
 - 1) Travel Expenses
 - 2) Reprographic and Internet Usage Expenses
 - 3) Required Student services fess at the host institution
 - 4) Books and academic supplies
 - 5) Administrative Fees, if any and cultural events

ii) Exchange of Researchers

With the objective of strengthening ties through joint projects, internship research activities, cultural of both research guide, guidance and facilities under the MoU. The researchers will maintain their status as student research scholars at their home institution for the duration of the exchange.

(a) The researchers will maintain their status as a student research scholar at their respective bonafide university for the duration of the exchange.

(b) The researchers will be allowed to make use of the books, publications, theses and other research facilities including research guide available in various department of both universities with the prior approval.

iii) Research and resources

Dr. B.R. Ambedkar University of Social Sciences, MHOW and Bundelkhand University, Jhansi agree to promote remote research and realise collaborative projects, giving priority to interdisciplinary works.

3. Duration of MOU

a) The Agreement will take effect from the date of its signing, changes to this agreement shall be made by mutual consent between both Institutions. In case of disagreement, the Institute willing to depart from the agreement shall, wherever possible, give two months' notice of its intention to do so. The Agreement shall be reviewed after a period of three years.

b) There is no financial and legal commitment on the part of both the parties to take up any program mention in this MoU. If there is any financial consideration, it will be dealt separately as per proposer's parent institutional administrative and financial approvals or as per mutual agreement.
