This is the MOU reached between Society for Development Alternatives, TARAgam Orchha, District Niwari, M.P., having its headquarters at B-32, Tara Crescent, Qutub Institutional Area, New Delhi -110016, hereinafter referred to as First Party, and Bundelkhand University, Jhansi, U.P. State University, hereinafter referred to as Second Party.

Society for Development Alternatives (DA), the world's first social enterprise dedicated to sustainable development, is a research and action organization striving to deliver socially equitable, environmentally sound and economically scalable development outcomes. Since inception DA is dedicated to systemic transformation. It started by analyzing the changes that were needed in the existing societal and economic order to ensure that the wellbeing of the marginalized and the health of the environment is maintained and regenerated, for long into the future.

And whereas the Second Party Bundelkhand University (BU), Jhansi is desirous to impart education, Knowledge, Skill development, Personality Development, Training and Employment opportunities.

## PURPOSE

The purpose of this MOU is to develop academic, educational, practical exposure, work assignments, field visits, assisting in reporting and programme formation and other cooperation on the basis of equality and reciprocity and to promote sustainable partnerships and mutual understanding between the Development Alternatives, TARAgam Orchha Tigela Mod, Jhansi Orchha Road District Niwari, Madhya Pradesh- 472246 and Bhaskar Institute Of Mass Communication And Journalism (BIMCJ), Bundelkhand University, Jhansi, Uttar Pradesh.

## SCOPE OF ACTIVITIES AND COST

DA and BU aim to undertake cooperation in areas that may include, but are not restricted to, the following:

Activity / Event	Cost
Honorarium Internship (includes field visits, script writing, recording, editing and packaging of radio programs)	Rs.5000/- per student Min. Training duration- 1 month; Min. batch size- 10 students
Honorarium student assistance for reporting and script writing	
Honorarium Continuing education programs formation	As per mutual discussion and agreement.

**Note:** The cost of each activity/event mentioned in the table above will be revised each financial year with a hike of 10% with the consent of both parties. With mutual agreement, new activities/events can be added to the table along with corresponding cost. A memo signed by both the parties will be attached with the MOU each time the rates are revised or when new activities/events are added.

**ACTIVITY AGREEMENTS**

Before any activities may be implemented, the parties shall discuss the relevant issues to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the activity. Activity agreements will include such terms as the following:

- a) Elaboration of the responsibilities of each institution for the agreed upon activity.
- b) Specific schedules for the activity.
- c) Budgets and sources of finances for the activity.
- d) Detailed management of intellectual property rights and publications.
- e) Any other items deemed necessary for the efficient management of the activity.

**COORDINATORS**






Coordinators shall notify their counterparts should a new person be named to the position.

**RENEWAL, TERMINATION AND AMENDMENT**

5.1 This MOU shall remain in force for a period of TEN years from the date of the last signature. This MOU may be extended by the written consent of the parties.

5.2 This MOU may be terminated by either party giving written notice to the other party at least 60 days in advance of the stated termination date. Termination of this MOU shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.

5.3 This MOU may be amended only by the written consent of the parties.
