SCFEL, MGCU and BU aim to undertake cooperation in areas that may include, but are not restricted to, the following:

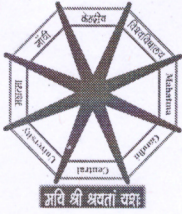
- Joint research/Project/programme/E-learning activities





**RENEWAL, TERMINATION AND AMENDMENT**

Termination of this MOU shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.
