MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is executed on this!!.......day of May 2022 at Delhi.

Bundelkhand University, seat of higher learning came into existence on August 26, 1975, vide Government of Uttar Pradesh Notification No. 10/15-60/74 under the provision of the U.P. Universities Act. However, though belonging to the younger generation of the Indian Universities, the Bundelkhand University has fast transformed into a University of excellence offering opportunities to the aspiring youths to pursue higher education through its Registrar presently, Shri. Vinay Kumar Singh, of the ONE PART.

AND

Shriram Institute For Industrial Research, (a unit of Shriram Scientific and Industrial Research Foundation, a Society registered under the Societies Registration Act XXI of 1860) having its office at 19, University Road, Delhi – 110007, (hereinafter referred to as "SRI"), through its Director, presently Dr. Mukul Das, of the OTHER PART.

Bundelkhand University and SRI are hereinafter referred to individually as a "Party" and collectively as the "Parties".

Whereas, Shriram Institute for Industrial Research, founded in 1947, is an independent, self- sustaining, not-for-profit multidisciplinary contract research institute conducting research and development in the areas of special significance to industry, government agencies and other organizations. SRI is committed to develop, innovate, analyze, and apply technology for products and processes. SRI has built a formidable reputation for quality and reliability and is a well-known name across the Industries.

Whereas, sharing a common desire to explore, extend and strengthen a functional relationship, Bundelkhand University and SRI have agreed to collaborate for joint projects in the areas of Material Science, Analytical Sciences, Toxicology, Drug & Pharma, Food & Farm and Environmental Sciences, as also in order to share the facilities and expertise available in each







other's institution hereby sign a Memorandum of Understanding which are as follows:-

- Experts/ Scientist staff working at SRI may visit Bundelkhand University to share the facilities and expertise available in the other's institution as and when required.
- 2. Teachers/ Students/ Researchers working at Bundelkhand University may visit SRI to utilize the facilities and expertise available in SRI w.r.t training as and when required.
- 3. SRI and Bundelkhand University may provide short-term training to students, faculty members and scientists (10 person in a year) of each other's institution in their areas of specialization by respective Professors or scientists on the request from the Institution. The researchers from SRI can register for Ph.D with Bundelkhand University.
- Bundelkhand University may provide training to technical employees of SRI by their Professors in their areas of specialization at the request from SRI for the aforesaid purpose.
- SRI and Bundelkhand University may work on collaborative projects on research and may apply for funding jointly to national and international agencies.
- SRI and Bundelkhand University will make its facilities and faculty available for the development of skill in advanced areas of industrial and bio-safety research in different sectors.
- 7. Bundelkhand University & SRI may organize workshops / seminars/ courses jointly on mutual benefits.
- Bundelkhand University & SRI will independently cover the cost of research and other expenditure incurred in connection with the research collaboration as per mutually agreed terms.







- 9. Bundelkhand University & SRI may jointly encourage and promote innovative ideas in incubation programme.
- Bundelkhand University & SRI will jointly share any work carried out by their employees either in the form of publication or patent.
- 11. This MOU shall come into force immediately upon signature by authorised representatives of Bundelkhand University & SRI. The MoU shall remain in force for a period of 5 (Five) years initially and subsequently can be renewed by mutual consent of the Parties in writing.
- 12. This MoU may be terminated by either by giving notice of 30 (thirty) days in writing without assigning any reasons.
- 13. The terms of this MoU can be modified/ altered in writing under signatures of respective representatives from Bundelkhand University and SRI.
- 14. During the tenure of this MoU and 5 (five) years thereafter the Parties undertake on their behalf and on behalf of their employees/ representatives/ associates/successors to maintain strict confidentiality and prevent disclosure thereof, of all the information and data exchanged/ generated during the tenure of this MoU for any purposes other than in accordance with this MoU.
- 15. Dispute resolution- In case, there is a dispute relating to any aspect of cooperation, or any disagreement arising out of the application, interpretation or implementation of this MoU, both the parties shall endeavor to exercise best efforts to negotiate their differences in a spirit of independence, mutual respect, and shared responsibility. If amicable settlement cannot be reached within 60 (sixty) days from the date of occurrence of the dispute, the matter under dispute shall be finally settled without recourse to the Courts, by mediation or through arbitration as per the provisions of the Arbitration & Conciliation Act, 1996. The language of the arbitration proceedings shall be English and the venue of arbitration shall be at Delhi.

16. Governing Law- This MoU shall be governed in all respects by the laws of India. This MoU shall be subject to the jurisdiction of Courts of Delhi/ New Delhi only.
