1.0 PURPOSE

The purpose of this MOU is to develop academic and educational cooperation on the basis of equality and reciprocity and to promote sustainable partnerships and mutual understanding between the BUNDELKHAND UNIVERSITY, JHANSI, UTTAR PRADESH, INDIA and VIKRAM UNIVERSITY, UJJAIN, MADHYA PRADESH. Both BU and VU may be referred to individually as the "party" or collectively as the "parties".

Whereas **VIKRAM UNIVERSITY** was established in Ujjain on 1 March 1957. Shri Ranchod Lalji Dhabai donated the land for it from Barnagar. The foundation stone of Vikram University was laid by the then Home Minister of India Shri Govind Vallabh Pant on 23 October 1956. The function was presided over by the Rajpramukh of Madhya Bharat State Late Jiwajirao Scindia. The Madhya Pradesh Universities Act was amended and published in Madhya Pradesh Gazette on 28 June 1985. As per the amendment, University Jurisdiction was redefined and demarcated in accordance with the Revenue districts of Ujjain Division, including Ujjain, Ratlam, Mandsaur, Neemuch, Shajapur and Dewas.

And whereas the Second Party **BUNDELKHAND UNIVERSITY**, Jhansi is desirous to impart education, Knowledge, Skill development, Personality Development, Training and Employment opportunities. This seat of higher learning came into existence on August 26, 1975, vide Government of Uttar Pradesh Notification No. 10/15-60/74 under the provision of the U.P. Universities Act. However, though belonging to the younger generation of the Indian Universities, the Bundelkhand University has fast transformed into a University of excellence offering opportunities to the aspiring youths to pursue higher education.

1.0 SCOPE OF ACTIVITIES

BU and VU aim to undertake cooperation in areas that may include, but are not restricted to, the following:

- a) Student exchange for research and study
- b) Exchange of faculty, staff and research scholars
- c) Joint research activities
- e) Continuing education programs
- f) Organization and participation in seminars, symposia, short-term academic programs and academic meetings
- g) Exchange of research and educational materials, publications and academic information
- h) Technical assistance

- i) Creation and marketing of electronic instruction media, including credit and non-credit courses
- k) Other, with mutual consent of both the parties.

3.0 ACTIVITY AGREEMENTS

Before any activities may be implemented, the parties shall discuss the relevant issues to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the activity. Activity agreements will include such terms as the following:





- a) Elaboration of the responsibilities of each institution for the agreed upon activity.
- b) Specific schedules for the activity.
- c) Budgets and sources of finances for the activity.
- d) Detailed management of intellectual property rights and publications.
- e) Any other items deemed necessary for the efficient management of the activity.

4.0 RENEWAL, TERMINATION AND AMENDMENT

4.1 This MOU shall remain in force for a period of TEN years from the date of the last signature. This MOU may be extended by the written consent of the parties.

4.2 This MOU may be terminated by either party giving written notice to the other party at least 180 days in advance of the stated termination date. Termination of this MOU shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.

4.3 This MOU may be amended only by the written consent of the parties.
